### **Superintendent's Remarks**

Met with Glenville State College at the Capitol with 13 other counties for the Home Grown Initiative, which is a part of a previously approved MOU. We signed the MOU at the Capitol and had resolutions passed in the House and the Senate.

Met with Thrasher. We now have some preliminary drawings of 2 of the "Safe Schools" entrances, but not yet ready for publication. They are also nearly ready for putting out bids for the roofing projects later this month or early next month, in anticipation of the bond sale in April. They are looking to do the HVAC and possibly one "Safe Schools" entrance this summer before we return in the fall.

Received feedback from the state today on our Critical Needs and Shortage policy that allows us to have retired teachers serve as substitute teachers for longer than 140 days, which is a state-wide rule and accepted by the Retirement Board. Although we have been going through our own policies to remove repetition, the Retirement Board requires that we have certain language in our policy that is duplicated in state code.

Spoke with Speaker Hanshaw at the Capitol, who indicated he wanted to hear from the superintendents. He then set in motion a hearing on Senate Bill 451 and State Board President David Perry has requested that all superintendents attend the Monday morning session.
