**Reports of Committees**

- 1. Roane-Jackson Technical Center Administrative Council (4/21/2020)

The new LPN instructor that was hired in February is now ready and will start next Monday. There is discussion for adults and students to continue for the rest of the school year. Cosmetology has been the tricky subject since it is considered a non-essential field. At some point in the class, they will need to cut hair. WVDE has been flexible with licensing requirements but it is difficult when it comes to hands-on work. Some instruction can work individually, but since Jackson County has been made a hot spot for Covid-19, our nursing students may not be able to accept by clinical sites for next year.

**Superintendent's Remarks**

Since contractors can still work, and Governor Justice has closed schools for the school year, many projects can start up sooner and therefore, finish ahead of schedule.

We are waiting on Cincinnati Flooring to get back to us with a start day for the flooring in SMS gym.

We fed another 1380 students today, which was down from the previous week, but we expect to have fluctuations in that number.

There should be plans going out soon for end of the year activities, especially for our Seniors and the transition plan for next year.

Until a vaccine and/or a successful treatment is available, we have to prepare for the possibility that we may go back and forth in and out of school dependent on how Covid-19 affects us in the future. It may be seasonal.

There has been a growing push for access to the internet, meals and health care. This has been a wake up call that shows how our kids are reliant on school. Referrals to DHHR for child neglect have been the lowest in a long time due to the mandatory reporters not seeing the kids everyday.
