Both counties are back up and running. The water plant project finally looks like they have permits approved to do the work in the summer. The welding shop instructors hope to be certified at a national level by AWS. This will hopefully happen soon. Recently, we've mentioned embedded credits, which is a CTE pathway that allows students to take 4 credits, covering the same content standards of another class, allowing them to get credit for this additional class. We hope to discuss this more in the future.

Superintendent's Remarks

Expect discussion on school calendar coming up. Also, personnel realignment packages are coming up. Due to some luck, the federal stimulus package, and good planning from last year, we should have a relatively soft impact this year.

We need to start planning on where our stimulus monies should go. We have 4 working groups ready, teaching and learning, student support, community engagement and classroom furnishings and equipment. We need to see where we need to go with our current supports for summer and beyond. With this large amount of funding that we will get once, we will need to invest in items that will last a while.
