

REGULAR MEETING OF THE BOARD OF EDUCATION OF THE COUNTY OF ROANE, HELD JULY 22, 2021, AT 6:00 PM, AT ROANE COUNTY HIGH SCHOOL, SPENCER, WEST VIRGINIA

Presentations

1. Positively Charged

The AP Environmental Science class, taught by Ms. Deweese, tested well on their AP test. On a test where national, only 25-30% of students score a 4 or higher, all 6 of her students scored a 4, which guarantees them college credits.

Also, on SAT School Day, our 11th graders took the in-person SAT as part of the overall summative assessment for high schools. For the composite scores, our students beat the state average, while scoring below the national average. For the English and Math benchmarks, the percentage of our students that met the English and Math benchmarks was higher than the State average, but below the national average. Our percentage that met the English benchmark was only 1% away from matching the national average and beating the state average by 10%. This shows encouraging progress.

Superintendent evaluations were discussed.

There were a couple of personnel changes. Mr. Shepherd was transferred from the Technology Integration Specialist and the Coop Coordinator to just the Technology Integration Specialist and moved Ms. Wilkinson to the Co-op Program. Her services could be shared with us to coordinate any co-op programs that our CTE Program might have.

The ongoing water plant issues were discussed at a previous meeting, but the bids were about double the estimate. They have a few options, but the most hopeful option is to go back to the state and ask for help from the Governor's office or legislature since this is an infrastructure need.

Superintendent's Remarks

The GEMS and WEMS construction projects have started. So far, it has mostly been demolition. At GEMS, there are barriers set up to keep kids away from the computer lab and that entrance. Structural engineers will be coming to assess the building. Paving should take about 4 days and start working on the French drain this week.
