There was a pre-bid conference for the roofing and safe schools entrance project at the current Spencer Middle School earlier this week. Once these projects are finished, everything in the bond program except for paving and lighting at RCHS will be completed. We can then look at the athletic program and the remaining bond funds. We have quotes for bleachers at WEMS and a rock wall at SES.

We recently consulted with a school furnishings company on designs for our upcoming STEAM labs. We hope to get started on that in the spring and to be paid for from the ESSER funds.

The initial drawings for the new SMS design should be finished and submitted for review on December 14th and we should have a video soon to show to the public. This is an exciting time for Roane County.
