Superintendent's Remarks

We have hired bus operators as substitute maintenance workers to address the concerns about the cleanup we need at our schools. We are still struggling to find an electrician/HVAC worker.

At conferences last week, the social-emotional well-being of staff continues to be the concern for many and we are all looking for better ways to recruit and retain our staff.

With the legislative session is around the corner, the superintendents have put together a list of priorities. At the top of the list is a change the state aid formula to allocate more funding for special education needs such as teachers and aides. We also ask for more money to be provided for SBA facilities projects. The State Superintendent has endorsed a plan to fund aides in 1st and 2nd grades.
