On Tuesday, we discussed lack of continued LPN instructor. A few possible interviews are

coming up.

Electrical, HVAC, and Dental Assistant are three new programs under consideration. The "legislative ask" will be for WVSBA to provide funding to build those classrooms and purchase equipment since there is a need for these programs.

The Council on Occupation Education (COE), a recognized national accrediting agency, has reaccredited the center to make them eligible to offer Pell grants. Also, the welding society, AWS, has accredited them so they can be an advanced testing facility.

Superintendent's Remarks

The legal matter we discussed at a recent board meeting seems to be going well and wrapping up soon. We may see an agenda item to consider at the next board meeting.

SES, GEMS and WEMS are part of an EPA program to examine the amount of lead in the drinking water at schools. The water fixtures have been tested at SES, GEMS and WEMS and the results will be posted at <https://westvirginia.120wateraudit.com/> and reported to the public. Sixty-five of our fixtures meet the EPA standard of less than fifteen parts per billion, but one fixture at SES tested above that limit. The water fountain has been shut off permanently and fortunately, most water fountains have had little to no use in the past couple of years, especially where this one is located. We will be testing whether it's the old plumbing or the fixture itself.

Construction updates: The masonry is up at the safe schools entrance for GEMS. The framing should be completed within the next few weeks. For the safe school entrance at WEMS, they will be moving Mrs. Garner into her office soon so they can start working on the clinic. Both school projects should be proceeding quickly from here. Initial stages of the SMS entrance progress started demolition of tiles and installation of a safety wall this week. The pre-bid for demolition of the old board office was held previously and we will see how these bids go.

Finally, there are a thousand open teaching positions across the state. This has been a struggle for some time now. Our universities have not been not producing many candidates so we must lead and innovate through TPG or alternative certification programs. There were announcements by state board to address the teacher shortage and they were not well received by the teaching community due to the focus only on recruitment instead of retention. To be successful, we surely have to focus on both.
