**Reports of Committees**

1. Roane Jackson Technical Center Administrative Council (7/19/2022)

Ms. Richardson reported first, that they are getting ready for approval of the bids for the drainage issue, but it is more expensive than previously quoted.

Second, they have hired the 2nd LPN instructor, along with hiring an instructor to teach Criminal Justice.

Third, there are also issues with the land they are prepping for the truck driving field.

**Superintendent's Remarks**

The superintendents meeting was cancelled 2 weeks ago, but the superintendent association has professional development on August 11th to learn about legal positions on 2 constitutional amendments and state policy.

The state has now flipped the switch on WVEIS 2.0, but there are issues with it not talking to the other systems, such as Schoology.

Mason County Superintendent, Keith Burdette, and I both attended a National Superintendent Forum in Florida. It was good to see that we were not the only ones with staffing troubles. What was good about this conference is that we really focused on leadership.

Though not all the details are worked out yet and we still need some supplemental funding to get the new SMS built, this is a momentous occasion and I thank the board for their support and direction throughout this venture.
