I attended the State Board of Education meeting yesterday, on behalf of the WV Association of School Human Resources Officers. I used the delegation portion of the meeting to bring up the coming expiration of ESSER funds and the general lack of leadership candidates.

The legislative session opened yesterday and the Senate passed 23 bills on Day 1. One of the educational bills that was passed allows counties to unilaterally leave the tech centers and build their own, which would leave the remaining county(ies) to deal with the whole cost. There were a few others and they seem to be moving quickly already.
