1. Roane Jackson Technical Center Administrative Council (3/21/2023)

The council authorized pursuit of an SBA project at the center to build a new building to house HVAC and electrical programs. The estimate from ZMM for a 10,000 square foot building was about \$5.6 million.

Also, Mr. Hosaflook has indicated his intention to start an electrical program in the upcoming school year at the former Ravenswood Middle and that there would be no charge for any Roane County students that wish to enroll.
