### **Superintendent's Remarks**

On Monday and Tuesday, members of our leadership team were in Charleston for the Science of Reading training. They are there again today and tomorrow learning how to implement and train teachers and staff.

On Tuesday, I was at the quarterly meeting of the Commission of Professional Teaching Standards. We heard updates about what efforts are being made to help with the teaching shortages and certification issues. There was a lot of good alternative education data across the state, which has only produced about 200-250 teachers. This makes up only a small percentage of the shortage.

LSIC at GEMS requested November 9th for their annual meeting with the BOE.
