To celebrate the almost end of the first semester, winter benchmarks in Star 360 will wrap up this week.

In math, we've dropped from 62% of students below 40th percentile ranking to only 50%, meaning 140 kids have moved out of the concern area. Much of this improvement has been made at SES. Being a CSI school, that is a great success. Their math benchmarks show kindergarten up 29%, first grade is up 43%, second grade is up 22%, third grade is up 14%, and fourth grade is up 11%.

In reading, we had only 4% moving from below to above the 40th percentile ranking. This is an overall improvement that we hope to see more of by the end of the year.
